### ACT 159

On November 29, 2006, House Bill 2133 was signed into law.

The following change takes effect January 28, 2007:

- ❖ Special registration plates may be issued for a vehicle that is owned by a business, as long as the business owner or officer making application for the plate belongs to the group for whom the plate is available.

The following change takes effect November 29, 2009:

- ❖ The Department of Transportation has the authority to issue identification cards to any person 10 years of age or older.

### BUREAU OF MOTOR VEHICLE FORMS REMINDER

This is a reminder to agents that we will begin our transition to provide a number of forms on our Web site only.

All forms that are available on our Web site will no longer be provided in a printed format. The printed supply of these forms may be ordered until January 12, 2007 or until the current printed supply is depleted.

Attached is a list of forms that are on the Departments Web site and no longer stocked.

### REMINDER TO DEALERS

Dealerships that have authorized persons coming into the Bureau's Dealer Counter Area are reminded that they are only allowed one piece of retail dealership work per day to be processed at the windows. They may drop off additional work at the counter to be processed through the mail. In addition, authorized persons are only permitted to have work processed for one dealership, not multiple dealerships. Authorized persons bringing paperwork to the counter, must have their driver's license and a dealer registration card or copy of the dealer summary card every time they submit work to be processed at the counter.

### LOST OR STOLEN DEALER PLATE REMINDER

Section 1333 (a) (Lost, stolen, damaged or illegible registration plate, application for new plate) of Title 75, Pennsylvania Consolidated Statutes and Section 53.6 (c) (Lost or stolen plate) requires the registrant of a vehicle to notify the Department within 48 hours of discovering the loss or theft when any registration plate is lost or stolen. In addition, both of these sections require that the police are notified of a lost or stolen plate. Form MV-353, "Application for Replacement of Dealer or Miscellaneous Motor Vehicle Business Registration Plate, Card or Renewal Sticker," is used when a dealership is requesting a replacement of a lost or stolen plate. In order for us to properly document the plate that was lost or stolen, a copy of the police report, or an incident report number, issued by the law enforcement officer, must be attached to the form. Failure to supply these documents will result in rejection of the application. Form MV-353 is being updated to reflect this information.
