Fee Adjustments as a Result of Act 89

Act 89, which became law on November 25, 2013, amends many sections of Title 75, including adjustments to registration fees effective July 1, 2014. Act 89 represents an investment in Pennsylvania's future: increasing public safety, driving commerce, creating jobs and providing reliable funding for our transportation needs without leaving the bill to our future generations.

The Act amended the following sections of Title 75:

- Section 1913 adjusts the fee for motor home registrations from:
 - Class 1 = \$45 to \$65
 - Class 2 = \$63 to \$90
 - Class 3 = \$81 to \$116
- Section 1920(a) adjusts the fee for trailer (10,001 pounds or more) registrations from \$27 to \$35.
- Section 1920(c)(1) adjusts the fee for permanent trailer (10,001 pounds or more) registrations from \$135 to \$165.
- Section 1921 adjusts the fee for special mobile equipment registrations from \$36 to \$52.
- Section 1922 adjusts the fee for implements of husbandry registrations from \$18 to \$26.
- Section 1924 adjusts the fee for farm vehicle registrations from \$76.50 or one-third of the regular fee, whichever is greater to \$110 or one-third of the regular fee, whichever is greater.
- Section 1925 adjusts the fee for ambulance, taxi and hearse registrations from \$54 to \$77.
- Section 1926(a) adjusts the fee for dealer and miscellaneous motor vehicle business registrations from \$36 to \$52.
- Section 1926(b) adjusts the fee for motorcycle dealer registrations from \$18 to \$26.
- Section 1926(c) adjusts the fee for motor-driven cycle dealer registrations from \$9 to \$13.
- Section 1926.1 adjusts the fee for farm equipment dealer registrations from \$243 or one-half of the regular fee, whichever is greater to \$349 or one-half of the regular fee, whichever is greater.
- Section 1933 adjusts the fee for commercial implements of husbandry registrations from \$76.50 or one-half of the regular fee, whichever is greater, to \$110 or one-half of the regular fee, whichever is greater.

The new fees will appear on registration renewal notices sent to customers for the above registrations that have a current expiration date of July 2014 or later. PennDOT will begin accepting the new fee on April 27, 2014 for registrations renewed through PennDOT's Driver and Vehicle Services website for the registrations listed above that expire July 2014 or later. Updated motor vehicle forms and publications reflecting the above fee changes will be available on the PennDOT website on April 27, 2014. Beginning April 27, 2014, you must use the updated forms.

Please ensure when completing applications impacted by these fee adjustments that you charge the correct fee. Failure to charge the correct fee for registrations with an expiration date of July 2014 or later may result in the application being rejected for insufficient fees.
