This form may be used with Form MV-1, "Application for Certificate of Title," or Form MV-4ST, "Vehicle Sales and Use Tax Return/Application for Registration," to obtain a motor home classification for a van or mini-van **that was originally equipped as a motor home**. In order for the body type to be changed to a motor home, the vehicle's certificate of title must be attached and the appropriate title and registration fees attached.

If any alterations were made to the vehicle to qualify as a motor home, this form may not be used. Form MV-426B must be completed for vehicles not originally equipped as a motor home and the vehicle must go through the enhanced vehicle inspection process.
