D REASON FOR REFUND REQUEST

- 1. Unused Registration Card - Return registration card and plate - must be requested within 14 days of the previous/old registration expiration date.
NOTE: Items 2 thru 5 must be requested within 90 business days of product issuance date.
- 2. Unused Registration Plate (**NOTE:** Once the registration plate has been placed on the vehicle, it is classified as used. Refunds of fees (totally or partially) are not issued on used registration plates.)
- 3. Requesting Retired Status - Include Form MV-140 or Form MV-371.
- 4. Disabled Veteran - Include Department of Veterans Affairs Awards Letter or Promulgations Letter.
- 5. Unused Camera Card - If surrendered for medical reasons, you may be eligible for a free ID credential. See Form DL-54A, "Application for Initial Photo Identification Card."
- 6. Double or Duplicate Payment - Include proof of payment.
- 7. Financial Responsibility (FR) - Civil penalty and/or restoration fee.
- 8. Partial Motor Carrier Vehicle Registration Fee - For motor carrier vehicles in excess of 17,000 lbs. which are stolen or demolished and have a non-repairable certificate or certificate of salvage.
