**ISSUANCE OF “BI” ANNUAL INSIDE INSPECTION STICKERS**

Beginning in early September, we will again be issuing annual inside safety inspection stickers for 2016-2017 using the “BI” designation. There is no difference between stickers beginning with “AI” and “BI.” The 2017-2018 annual inside safety inspection stickers will begin with “AI.”

**ORDERING INSPECTION STICKERS**

Beginning October 1, 2016, the Department will be issuing the new 2017-18 safety and emissions inspection stickers.

Between now and October 1, you should be careful not to order more stickers than necessary to perform annual inspections through December 31, 2016 and semi-annual inspections through June 30, 2017.

When placing an order for new safety or emissions inspection stickers, it is important that you indicate which inspection years you are requesting. To order the current 2016-17 safety or emissions inspection stickers, simply complete an MV-436A Inspection Sticker and Insert Order Form as usual. **Please allow 14 business days for your sticker orders.**

You may place your orders now for 2017-18 safety or emissions inspection stickers but they will not be processed until October 1, 2016. **If you wish to order 2017-2018 safety or emissions inspection stickers please write 2017-2018 in large numbers across the top of your MV-436A Inspection Sticker and Insert Order Form.** Unless you indicate **2017-1018** at the top of the form, your order will be processed for 2016-17. MV-436A forms marked 2017-18 will not be processed before October 1, 2016.

The 2017-18 stickers may be used simultaneously with the 2016-17 stickers. The 2016-17 stickers may be used for inspections on vehicles with expiry dates up to December 2016. The 2017-18 stickers are needed by November 1<sup>st</sup> for vehicles with a January 2017 expiry. Once you begin to use the new 2017-18 stickers, a separate MV-431 or MV-480 must be started. Please be aware that if your payment is made with a check returned for insufficient funds, your inspection privileges are subject to suspension in accordance with the schedule of penalties found in Section 175.51 of the Vehicle Equipment and Inspection Regulations.

We will add your email address into our shipping database. When we prepare your package for shipment, an email will be sent to you with the UPS tracking information.

Semi-Annual (SI) - \$4.00 each

Inserts – No charge
