Elimination of Hard Copy Publications

In an effort to "go green" while saving important Commonwealth dollars, PennDOT is no longer printing several of its most widely used publications. The affected publications are:

Pub 45, Vehicle Equipment and Inspection Regulations; and Pub 763, Emissions Inspection Program

Once the current supply is depleted, the publications will no longer be available for purchase through the Sales Store. Each publication is available online for downloading and/or printing. Students may print their own, or the school may print/copy each publication. Should a school want to print these publications, a **Permission to Use Copyrighted Work** form must be submitted (see attached). Schools may customize the cover with approval.

In the near future, each of these publications will be released as an 'app' for individuals to download onto their electronic devices.
