SPECIAL EDITION

Act 109 of 2014 was signed into law July 2, 2014, and will be effective September 2, 2014. This Act amends multiple sections of Title 75 as follows:

Section 1307(a.1) - Seasonal Registration - a gross vehicle weight rating limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1338(a) - Persons with Disability Plate and Placard - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1340(a.1)(2) – Vintage Registration Plates - The Pennsylvania registration plate issuance dates changed from between 1906 and 1975 to between 1906 and 1976.

Section 1342(a) - Severely Disabled Veteran Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.; the restriction of one severely disabled veteran registration plate per veteran was removed.

Section 1342(c) - Disabled Veteran Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.; the restriction of one disabled veteran registration plate per veteran was removed.

Section 1342(d) - Prisoner of War Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.; the restriction of one prisoner of war registration plate per ex-prisoner of war was removed.

Section 1346 - Purple Heart Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1348 - Pearl Harbor Survivors - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1350 - Veterans of Korean War - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1350.1 – Korean Defense Service Medal - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1351 - Veterans of Persian Gulf War - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1352 - Wild Resources Conservation Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1352.1 – Appalachian Trail Organization Plate – an issuance fee adjustment to \$25. Please note: Organizations may charge a fee in addition to PennDOT's issuance fee.

Section 1353 - Preserve Our Heritage Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1355 - Pennsylvania Zoological Council Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1356 - Expeditionary Forces Medal Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1357 - World War II Veterans Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1359 – Steel Worker Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1360 – Veteran of Vietnam Conflict Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1362 – Iraqi Freedom Veterans Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1363 – Operation Enduring Freedom Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1364(a) – Honorably Discharged Veteran Plates - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1364(b) – Honoring Our Veterans Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1365 – Gold Star Family Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1366.1 – United States Military Airborne Units Plate - a registered gross vehicle weight limit increase for qualifying vehicles from 10,000 lbs. to 14,000 lbs.

Section 1931(b) – Organization Registration Plate – an issuance fee adjustment to \$25. Please note: Organizations may charge a fee in addition to PennDOT's issuance fee.
