FARM EQUIPMENT DEALER - A dealer who sells vehicles designed or used exclusively for agricultural operations and only incidentally operated or moved upon highways, including, but not limited to, farm tractors, choppers and bailers.

USE OF FARM EQUIPMENT DEALER REGISTRATION PLATES - A truck or truck tractor bearing farm equipment dealer registration plates shall be used solely in the business of the dealer and operated exclusively by the dealership or its employees only when the vehicle is used: (1) for delivering farm equipment to a farm for the purpose of sale, demonstration, loaning to customers whose farm equipment is being repaired or loaning to prospective purchasers; (2) for pickup of new farm equipment from the manufacturer or distributor; (3) for pick-up of used farm equipment for the purpose of resale; or (4) for inspection, repair or servicing the vehicle. The registration weight of the vehicle must be over 11,000 lbs.

Farm equipment dealer registration plates may be personalized. Should you choose to personalize your farm equipment dealer registration plate, please complete and attach Form [MV-904D, "Application for Personalized Dealer Registration Plate,"](#) to this application. **NOTE:** There is an additional \$128 fee required with personalization requests.
