SB 1091/Act 73, SB 180/Act 90 and SB 945/Act 149

Act 73 - Contributions for Pediatric Cancer Research and Establishing Pediatric Cancer Research Fund

SB 1091/Act 73, "Contributions for Pediatric Cancer Research and Establishing Pediatric Cancer Research Fund," signed into law on June 28, 2018, added Section 1321 to Title 75, the Pennsylvania Vehicle Code. This addition allows customers to contribute \$5 to the Pediatric Cancer Research Fund through a renewal of vehicle registrations, driver's license or identification card completed on PennDOT's publicly accessible website (PennDOT's Online Services Center). Contributions shall be used exclusively for pediatric cancer research approved by the Pennsylvania Cancer Control, Prevention and Research Advisory Board.

The implementation date for this act is August 18, 2019.

Act 90 - Governor Robert P. Casey Memorial Organ and Tissue Donation Awareness Trust Fund Contributions

SB 180/Act 90, "Governor Robert P. Casey Memorial Organ and Tissue Donation Awareness Trust Fund Contributions," signed into law on October 23, 2018, amended Section 8621(a)(1) and (b)(1) of Title 20, the Decedents, Estates, and Fiduciaries, to allow customers to donate \$3 to The Governor Robert P. Casey Memorial Organ and Tissue Donation Awareness Trust Fund at the time of renewal of a registration and at the time of an initial or renewal of a driver's license or identification card.

The implementation date for this act is August 18, 2019.

Act 149 - Contributions to Veterans' Trust Fund

SB 945/Act 149, "Contributions to Veterans' Trust Fund," signed into law on October 24, 2018, amended Section 1320(a)(3) of Title 75, the Pennsylvania Vehicle Code to allow customers who are applying for a two-year registration renewal through PennDOT's publicly accessible website to contribute \$6 to the Veterans Trust Fund. Renewals processed other than through the PennDOT website may only donate \$3.

The implementation date for this act is August 18, 2019.
