#### Online Registration Card Printing Via the Dealer Agent Services (DAS) System

Dealers using PennDOT's Dealer Agent Services (DAS) System will see a change in the print out of their registration credentials. This change will support the printing of larger volumes of registration credentials by a dealership.

With this change, dealers will notice the registration cards for dealerships will be converted to a PDF file prior to printing. This will allow dealerships and/or dealer staff to print a larger volume of registration cards online with minimal system impacts. With the registration cards being converted to PDF file to be printed, the cards may have slight format changes. The size of the registration cards and font will be slightly smaller. Samples of the current registration and the new registration card can be seen on the next page.

This system enhancement took effect February 3, 2020.
